UNITS LED TV ATLEAST 65 INCHES WITH ACCESSORIES**

1. The **National Kidney and Transplant Institute (NKTi)** through **Corporate Operating Budget** of **2020** intends to apply the sum **NINE HUNDRED THOUSAND PESOS (Php900,000.00)** being the Approved Budget for the Contract (ABC) to payments under **ITB No. 20-086** with P.R. No. 47982C. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **National Kidney and Transplant Institute (NKTi)** now invites bids for the above-mentioned project. Delivery of the Goods is required within Sixty (60) calendar days. Bidders should have completed, within the past three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding shall be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. Interested bidders may obtain further information from NKTi and inspect the Bidding Documents at the address given below during *office hours*.
6. The complete set of Eligibility Requirements and Bidding Documents may be purchased by interested Bidders upon payment of a nonrefundable fee (Php1,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the NKTi, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
7. Bids must be duly received by the BAC Secretariat at the address below All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. The bidding activities shall be held at the **BAC Conference Room, G/F NKTi Main Building, East Avenue, Diliman, Quezon City**. The schedule of bidding activities is as follows:
